Issue(s): The issues are all the specific editions of the journal published in that year. Tip: Journals frequently publish issues around a certain theme, so all of the articles in that issue will relate to a certain topic. If you use the author's name in the text, you don't have to repeat it in the parenthesis at the end. Do not separate the author's name and the page number with a comma. See below for examples. Works Cited References for Journal Articles. Journal Title, vol. #, no. #, year of publication, page number(s). Database Title, DOI (if available) or URL (without https://) or Permalink. Access Date (optional). Example. This page contains reference examples for whole authored books, whole edited books, republished books, and multivolume works. Note that print books and ebooks are formatted the same. Book published with new foreword by another author. Several volumes of a multivolume work. 1. Whole authored book. Jackson, L. M. (2019). *The psychology of prejudice: From attitudes to social action* (2nd ed.). Provide the author of the whole book in the main author element of the reference. Then provide the name of the person who wrote the foreword, introduction, or other new part, in parentheses, after the word "with." In the example, Byock wrote a new foreword to the book by Kibler-Ross. Title of book (xx ed., Vol. xx). Location: Publisher. Edited Book. Some publishers title each volume of a multivolume work. In this case, include the volume number within the title when constructing your reference instead of citing it parenthetically. Here is an example reference to a volume with its own title (see also Example 24 on page 204 in the sixth edition of Publication Manual): Wyer, M. (2018). In the company of feminist science. In C. B. Travis, J. W. White, S. L. Cook, & K. F. Wyche (Eds.), *APA handbook of the psychology of women: Vol. 2. In the note, you will have the author's name, the title of the work, the publication information, and the page number: Andrew Byrd, "The Resurgence of the Meerkat," *Southern African Ecology* 32, no. 2 (2009): 221. You only need to create a note that contains all of this information once per paper. If you cite this source again later in the paper (say, in your sixth note), you would simply write the author, title, and page number, separated by commas: 6. Although it is the first page of the manuscript, this section is usually written right at the end. The title page contains all or a combination of the following elements. Always (Part 1 " discussed in this post). Article title. AUTHOR(S) OF ARTICLE For journal articles, put each author's last name, then a comma, then the first initial of the given name, then any additional initials. A period should follow each initial. Separate the last author from the second-to-last author with a comma and ampersand (&). Separate any additional authors by commas. One author. Keely, J. T. Two authors. Luggio, M. R., & Moulton-Kowinski, R. S. Three authors. Jackson, B. I., Jackson, G. P., & Jackson, I. G. YEAR OF PUBLICATION Even though a month or season of publication may be given for a specific journal, include only the year of publication, in parenthesis, and end with a period.
